3. Degrees, Diplomas and Certificates must be from Wafaq-ul-Madaris or Dar-ul-Uloom recognized by HEC /Government Recognized Institutes as applicable. For O-Level/ A-Level and Foreign Degrees, Equivalence certificate from HEC/ IBCC are required.
4. "Experience" means the work experience gained after date of attaining the required qualification till the closing date of Advertisement.
5. Minimum Age limit for above mentioned posts is 18 years whereas, upper age limit is 35 years. However, Upper age limit can be relaxed in case of specialized experience / qualification.
